Call to Order was made by Chairman George Radecsky ~ 6th Pennsylvania Regiment

Anne Henninger, 1st Maryland Regiment led the group in prayer.

John Tabor, United Train of Artillery led the Pledge of Allegiance.

The financial report was given from Treasurer Janie Ritchie ~ of the United Train of Artillery and 1st New Hampshire Regiment. (see Appendix B).

Motion made & seconded to accept the Minutes from the 21st Annual Meeting. Vote to accept, unanimous.

Sam Ricco ~ Adjutant brought up that no up-to-date paperwork was handed in and that the unit had 24 hours to hand in the proper paperwork. A motion to accept the Eames Rangers as a Full Member was made, and seconded. The motion passed with a unanimous vote.

Applicant: 2nd Virginia Regiment. Sponsor: 7th Virginia Regiment. Todd Post represented the unit.

Proposed artillery safety change. Presented by Jim Stinson, Proctors' Artillery:

Loaded Gun - Artillery, both in battery and battalion, upon completion of loading to have the #3 (Rammer) and #4 (Worm) gunners stand outside of the cannon wheels in a present arms position. The #1 (Firing) gunner will raise the linstock above their head, which will be the signal for a loaded gun ready to fire.

Cannon Misfire - When a cannon has misfired or its safety zone is violated, both #3 (Rammer) and #4 (Worm) gunners will cross both the rammer and the worm over the cannon barrel and the linstock will be lowered to the ground position. This is the signal to take just care to stay clear of the artillery piece.

A motion was made and seconded to accept the artillery safety change. The motion carried.

Motion to adjourn the 22nd Annual Meeting of the Continental Line was made & seconded. The motion passed with a unanimous vote.
