Department Coordinator Reports were then presented (8:47 AM – 8:52 AM):

Northern Department report given by Department Coordinator Al Soucey of the 13th Continental Regiment. Nothing new to report.

New Mid-Atlantic Coordinator Steve Santucci 2nd New Jersey Regiment introduced. Report included the following:

- School of the soldier events was successful but will not be held every year in order to keep it fresh
- Monmouth was successful. New scenario's were tried and a good relationship with Gary Stone (park coordinator) continues
- Raid on Wyoming was a good event and is hoped to be an excellent 2011 event
- Brandywine was highly successful with a great site and good scenarios. A large variety of troops from all over the country were present.
- Mt. Harmon was an interesting event and is considered an amazing site for its 2011 event.

Southern Department report given by Department Coordinator Anne Henninger of the 1st Maryland Regiment. Nothing new to report.

Election of Officers (8:53 AM – 8:55 AM)

Janie Ritchie of the United Train of Artillery and the 1st New Hampshire Regiment was re-elected to the position of treasurer by a unanimous vote. A nomination was

New Business (8:56 AM – 9:05 AM)

The process of a new unit becoming a member was briefly discussed. Chairman Chip Gnam of the 1st Virginia Regiment stated that a unit must come to their first Continental Line Meeting, where they are introduced by their sponsor. The Unit is then an "applicant unit", and is voted on at the *next* Continental Line meeting. This means that a unit must attend *two* Continental Line meetings, an introductory one to designate them as an "applicant unit", and a second meeting where they are voted on for full membership. The chairman agreed to post the official procedure on the Officer's Mess to clear up any discrepancies.

Procedural questions were raised for voting on national events. It was mentioned that some of the membership would like a list of possible events sent out prior to the Continental Line meeting so that they could properly gauge their unit's interest. This will hopefully be done before the 2012 Continental Line Meeting. Chairman Chip Gnam of the 1st Virginia Regiment stated that the criteria for a unit to cast its vote for a national event should be based solely upon whether or not that unit thinks it will be able to attend, and not on the basis of a unit simply endorsing an event.

Joint National Event Presentations by the Continental Line and the British Brigade in the Ballroom (10:11 AM – 11:40 AM)

The 2011 events presented were:

Wyoming Valley Massacre in Wilkes Barre, PA on July 16^{th} & 17^{th} (Sponsors: 24^{th} Connecticut and 42^{nd} Grenadiers)

Mt. Harmon Plantation in Elkton, MD on September 24th & 25th (Sponsors: 1st New Jersey and Royal Marines)

Both events had been voted as national events at last years meeting, and great support in both the British Brigade and Continental Line was re-enforced through another vote.

A scholarship fund was proposed by Mike Barbieri of Whitcomb's Rangers. Several members who give out scholarships on within their own units attested to the difficulty in administration and the selection process of such an undertaking. Chairman Chip Gnam of the 1st Virginia Regiment asked that a post be made on the Continental Line message board and that some sort of plan or presentation be made for the 2012 Continental Line meeting.

Chairman Chip Gnam of the 1st Virginia Regiment informed the membership that the Continental Line is a non-profit registered in the state of Pennsylvania, but it does not and never has had a 501 C3 status with the IRS. The process to acquire this status is already underway and is hoped to be completed before the 2012 Continental Line meeting.
