He also mentioned that a committee might be needed to administer any monies used. Another option would be to go through a scholarship administrative service (which charges a fee) or possibly investigate non-profits to administer monies for the Line. The option of donating monies to a college was also talked about. Chairman Chip Gnam of the 1st Virginia brought up the realities of actually funding such an undertaking. The Line in and of itself would not be able to financially support such an endeavor, and separate fundraising would need to be implemented.

The units have worked together as an advance company and would like to be deployed that way whenever possible. Bert Puckett of the 2<sup>nd</sup> South Carolina/3<sup>rd</sup> Dragoons mentioned that the Carolina units do the same thing in the South. Bob Healey of the 4<sup>th</sup> Legionary Corps reminded everyone that while it is a good thing that units work together, the overall composition of Brigades at national events is left up to the event organizers, and is usually based on manpower needs. When possible it is always a smart idea to brigade units together that have a good working relationship, but it is not applicable for every situation.

Bob Healey of the 4<sup>th</sup> Legionary Corps talked about Insurance DBAs ("Doing Business As"). (9:41 AM) There area few units in the line whose designation on their insurance documentation does not match their name submitted for the Continental Line census. These units must acquire a DBA (doing business as) attachment to their insurance stating that their policy covers their unit. All of these units have been contacted (and will be contacted again) and must comply BEFORE the next National Event. Former Chairman George Radeski of the 6<sup>th</sup> Pennsylvania stated that if a unit does not have their insurance in order, they should not be able to participate at Line events.
